BBNL has been incorporated as a Public Sector Undertaking (PSU)/ Company under Companies Act (1956) under the administrative control of Department of Telecommunications, Government of India (Ministry of Communications). It is an ambitious project of Government of India for the setting up of **BharatNet** (National Optical Fiber Network (NOFN)) to provide connectivity to all the 2,50,000 Gram Panchayats (GPs) in the country. This is to be achieved by utilizing the existing optical fiber and laying incremental cable of about 5 Lakh KM to all the Gram Panchayats.

SELECTION PROCESS

Interested & eligible candidates will have to appear for the **Electronics and Communication (EC), Computer Science and Information Technology (CS) and Electrical Engineering (EE)** Paper of GATE 2017. Candidates obtaining a valid score (Marks out of 100) shall only be eligible for the next stage of selection. The score is valid only if the candidate obtains more than or equal to the qualifying marks as fixed for the corresponding EC/CS/ EE paper of GATE 2017.

The selection process will include the Normalized Marks (Out of 100) obtained by the eligible candidates in the EC/CS/ EE paper of GATE 2017, followed by Personal Interview of the candidates who qualify in the GATE paper and are shortlisted category wise for interview.

Qualifying Marks in GATE 2017

The qualifying marks for GATE Examination shall be as per the criteria adopted by the GATE 2017 examination conducting authority for different categories in different disciplines.

Short listing of Eligible candidates Interview

Qualified candidates shall be short-listed category-wise for Personal Interview based on their normalized marks (Out of 100) in the corresponding EC/CS/ EE paper of GATE 2017.

Candidates shortlisted for the Interview shall be required to submit the documents as may be mentioned in their individual communication to be sent through e-mail/ Candidate login.

Empanelment of Candidates:

Based on the marks obtained in GATE 2017 and interview candidates will only be adjudged suitable for empanelment.

The Offer of Appointment shall be issued to the suitable candidates in the order of category wise merit and based on requirement.

Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination and verification of their character and antecedents from concerned authorities for being found fit for employment in the company.
