## **CORRIGENDUM**

## 3. Reservations / Relaxations / Concessions

- For post code 01 & 02 Reservations / Relaxations / Concessions would be given to OBCs/SCs/STs/PWDs/Ex-Servicemen/J&K Domicile/1984 Riots candidates as per guidelines issued by Govt. of India.
- For post code 03, 04 & 05, Reservations / Relaxations / Concessions would be given to OBCs as per guidelines issued by Govt. of India. However, for post code 03 & 04, all category candidates may apply subject to fulfillment of criteria as defined for a general category candidate and they shall be treated as general category candidate only. Besides, relaxation in age for PWD will be applicable as per Govt. guidelines.
- Post code 06 is a general category post and no relaxation/concession will be given to the reserved category candidates except PWD candidates as per Govt. guidelines. All category candidates may apply for the post subject to fulfillment of criteria as defined for a general category candidate and they shall be treated as general category candidate only.
