- i) To establish a Deep Borehole Observatory for directly measuring the in-situ physical properties of rocks, pore-fluids pressure, hydrological parameters, temperature and other parameters of an intra-plate, active, fault zone in the near-field of earthquakes before, during and after their occurrence.
- ii) To set up Research Laboratory to serve as the operational centre for carrying out the research activities related to the scientific deep drilling, borehole investigations, core analysis and research, and associated field/research studies.
- iii) To understand the mechanisms of faulting and physics of the earthquakes towards realistic seismic hazard assessment in an intra-plate environment.
