SELECTION PROCESS

(A.) Jr. Technician Trainee (Electrical)

1. Selection for the post of Jr. Technician Trainee (Electrical) shall consist of **Written Test only to be held at Patna and Ranchi.**
2. The written test shall be of objective type (each question shall have four answer options) of two hours duration consisting of two parts :-
 - (a) Part-I consists of Technical / Professional Knowledge Test with 120 questions having specific questions from respective discipline.
 - (b) Part-II consists of Aptitude Test with 50 questions on vocabulary, verbal comprehension, quantitative aptitude, reasoning ability, data sufficiency & interpretation, numerical ability etc.

***All questions carry equal marks (1 mark). Wrong & multiple answers would result in negative marks of ¼ .**

3. Candidates qualified in the Written Test shall be short listed for Trade test subject to a minimum cut-off percentage of marks of 30%.

4. Weightage to different parameters :

For calculation of final score of a candidate for empanelment, the weightage assigned to Written test & Trade test shall be indicated as mentioned below :

*Trade test will not have any weightage for calculation of final score but candidate need to qualify the same.

5. Empanelment of candidates & Offer of Appointment:

For the post of Jr. Technician Trainee, candidates who qualify in the written test and Trade test will only be adjudged suitable for empanelment in the order of merit.

The offer of appointment will subject to candidates being found medically fit in the Pre-employment medical examination to be conducted as per POWER GRID norms and standards of medical fitness.

6. The applicant will have the option to appear for Written test in Hindi /English language (Question paper will be in bilingual except questions of English language test.)

GENERAL CONDITIONS
