- 1. To entirely manage and oversee the project management and execution functions of all the verticals of the company.
- 2. To provide high level leadership in the areas of execution of Educational / HRD related projects and consultancy including strategic planning and management, business development, operations and corporate coordination and stake holders engagement activities.
- 3.Lead and manage, strategically and operationally, the activities, operations, resources and personnel of the service verticals as required, including: Operations and project management services covering online recruitment, Advisory services, IT / ICT Education Overseas Education services etc.
- 4. Oversee effective operational management and delivery of client's business requirement within agreed time frame, budget and quality parameters.
- 5. To establish excellent service delivery rapport with client organisation including Central/State Govt., PSUs, Autonomous Bodies, Institutions and Overseas Govt. for achieving the business and service delivery objectives.
- 6. Put in place systems and processes to ensure high level and timely service delivery.

- 2. Remuneration: Selected candidates will be placed in the IDA pay scale of Rs.43200-66000 (E-7) (under revision). Besides Basic pay, the incumbent will be entitled to DA, HRA/Leased accommodation, PF, Gratuity, Leave Encashment, Medical Facilities, Conveyance Allowance, Holiday Home Expenses, Soft Furnishing, Children's Education Allowance, Leave Travel Concession, Reimbursement of Professional Membership and Computer Advance as per rules of the company. The present Cost to Company (CTC) is approximately Rs. 18.35 Lakhs per annum for E-7. Performance Related Pay (PRP) would be payable extra. In deserving cases, additional increments can also be considered.
- 3. Mode of receipt of applications will be **ONLINE** only.
- 4. Age relaxation for SC/ST (5 years)/ OBC (3 years) / Ex-servicemen (05 years) & for PwD (Person with Disability) will be applicable as per Government Directives. Upper age limit is relaxable by 05 years for the candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period from 1/1/1980 to 31/12/1989.
