- (b) **Qualification** 10th class pass (any stream) Washerman & Support Staff (ER). 8th class pass House Keeper.

5. <u>SOL CLK/SKT/IM</u> (only for sons of Servicemen/Ex-Servicemen/Widows/War widows and real brothers of servicemen/Ex-servicemen of Bengal Sappers).

- (a) **Age** 17½ 23 yrs (born between 15 May 1994 and 15 Nov 1999 both inclusive).
- (b) **Qualification** Min 12th with 60% marks in aggregate and 50% in each subject. English and Maths/Accts/Book Keeping are compulsory at 12th or 10th level with 50% marks. Even if candidate is a graduate or has a higher qualification, percentage marks scored in class XII would take precedence.
