SAIL is looking to engage three (3) pilots to fly its Company aircrafts on contractual engagement basis:

- 1) Sr. Executive Pilot as PIC (P1) and 2) Executive Pilot as Co Pilot for Hawker 750 aircraft and 3) Pilot for King Air B-200 Aircraft.

The incumbents will be required to fly the aircrafts as per requirement and be responsible for ensuring compliance of requisite safety and regulatory norms prescribed by DGCA and manufacturer with regard to areas of operations, flight safety, FOQA, etc.

**Eligibility criteria** : The age, qualification and experience criteria are given below:

<b>ii)Essential Qualification</b>	i)ATPL with multi-engine rating ii) Type rated as PIC on HS-125 series aircraft
<b>iii)Essential Experience</b>	i) 3000 hours total flying experience including 2000 hours as PIC and at least 500 hours on jets ii)100 hours experience as PIC on HS-125 series aircraft.
<b>iv) Preferable Experience</b>	i) Rated as PIC on Hawker 750 aircraft, ii) Validity of Class-I medical, IR and PPC etc. for at least 3 to 4 months.
<b>2) Position:</b>	<b>Executive Pilot as Co-Pilot (P2) for Hawker 750 aircraft</b>
<b>i) Upper age limit:</b>	<b>50 years</b> as on <b>6<sup>th</sup> Jan 2018</b> - relaxable in case of higher qualified and experienced candidates.
<b>ii)Essential Qualification</b>	Current Indian CPL or equivalent DGCA recognized licence
<b>iii)Essential Experience</b>	Minimum 1000 hrs. total flying experience
<b>iv)Preferable Experience</b>	i) 500 hours flying experience on jet ii) Type rated as P2 on HS 125 series aircrafts iii) 100 hours flying experience on HS 125 series aircraft, including 50 hours on Hawker 750
<b>3) Position:</b>	<b>Pilot for King Air B-200 aircraft</b>
<b>i) Upper age limit:</b>	<b>40 years</b> as on <b>6<sup>th</sup> Jan 2018</b> - relaxable in case of higher qualified and experienced candidates.
<b>ii)Essential Qualification</b>	Valid Commercial Pilot Licence issued by DGCA or any other approved contracting state.
<b>iii)Essential Experience</b>	i)Minimum 500 hrs. total flying experience. ii)CPL endorsed with King Air B-200 aircraft, out of which at least 50 hours on King Air B-200 as PIC.
<b>iv)Preferable Experience</b>	100 hours flying experience in turboprop aircraft.

**Terms & Conditions of Engagement :**

1. **Period of engagement**-3 (three) years. Employment will be on contractual basis initially for 3 years and extendable thereafter.
2. **Place of posting**- Bokaro Steel City, Jharkhand
3. **Compensation package**- At par with industry standards. Terms & conditions negotiable.
4. **Selected candidates selected will have to sign undertaking/Indemnity bond to join SAIL.**
