## Instructions related to Qualification:

- A) Wherever CGPA/OGPA or other grades in qualifying examination is awarded, equivalent % (up to two decimal points) of marks should be indicated in the on line application as per norms adopted by concerned University / Institute. The Written / Online Test will consist of objective type question with 80% weightage for Technical knowledge and 20% for Quantitative Aptitude, Reasoning, General Awareness & Knowledge of English.

## 2) Trade Test :
