I. COMPANY PROFILE

Bharat Petro Resource Limited was incorporated in October, 2006 as a wholly owned subsidiary company of Bharat Petroleum Corporation Limited (BPCL), for carrying out the upstream oil & gas business of BPCL. The primary objective of the company will be to develop a focused approach towards building the exploration business and to implement the investment plans of BPCL at a quick pace. Assimilation of latest upstream technology, expeditious placement of competent human resources and developing necessary infrastructure shall also assume equal importance. BPRL is a schedule 'B' CPSE with the administrative jurisdication of Ministry of Petroleum and Natural Gas. The company employed 51 regular employees (Executives- 51, Non-executives-0) as on 31.03.2019.

Its Registered and Corporate Offices are in Mumbai, Maharashtra.

The authorized and paid up share capital of the Company were Rs.5,000 crore and Rs. 5,000 crore respectively as on 31.03.2019.

The shareholding of Bharat Petroleum Corporation Limited (BPCL) in the company is 100%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Managing Director is the Chief Executive of the Company and accountable to its Board of Directors and Government/Share holders. He is responsible for the efficient functioning of the company for achieving its corporate objectives and performance parameters.

3. For candidates from SPSE/Private Sector

- (a) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- (b) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- **4.** In the above cases, no request for relaxation or otherwise would be entertained.
