IIFT is a premier institution of education, training and research in the area of International Business set up by the Department of Commerce, Government of India. The Centre for Research on International Trade (CRIT) which is a part of IIFT has three Centres under it with the Centre for WTO Studies being one of them.

The Centre for WTO Studies was established at the Indian Institute of Foreign Trade in November, 2002. Centre is a professional body which conducts independent research and training programmes on the WTO and related matters.

For its research work on WTO **Dispute Settlement and Non-tariff measures like SPS-TBT issues**, the Centre intends to engage Legal Researchers either at the level of Research Associate (Legal) or Research Fellow (Legal) or Senior Research Fellow (Legal). The engagement shall be purely on contractual basis for a period of one year. The candidate should possess the following qualification:

LLB Degree/LLM Degree/Ph.D in Law with sound knowledge of computer application and packages [M.S. Word, M.S. Access, M.S. Outlook, Excel, Power Point]. The candidate should have good command over English (spoken as well as written) and should have interest in research activities.

Experience: The candidates having experience in research on WTO issues particularly **Dispute Settlement and Non-tariff measures like SPS-TBT issues** in any reputed organization shall be preferred.

Tenure: The appointment will be purely on contractual basis for a period of one year with a possibility of further extension based on the performance.

Emoluments: The Researchers shall be paid fixed monthly emoluments depending upon their qualification and experience as under:

Research Associate (Legal): Rs.30,000/- per month

Research Fellow (Legal) with one year experience: Rs.36,000/- per month

Senior Research Fellow having at least two year experience: Rs.48,000/- per month

Senior Research Fellow having Ph.D Degree in Law: Rs.54,000/- per month

In addition, a candidate engaged as a Senior Research Fellow/Research Fellow shall be entitled to Casual Leave, Earned Leave, medical facilities and LTC whereas a candidate engaged as a Research Associate shall be entitled to Casual Leave, Earned Leave and medical facilities only.

The selected candidate shall need to join immediately.

Candidates who have been awarded LLB Degree, LLM Degree and Ph.D in Law and who are in possession of their Degree/Provisional Degree should only apply. The candidates should also enclose a scanned copy of their degree/provisional degree along with their application failing which the application will be rejected.

Indian nationals having the above qualifications and experience should only apply and send their c.v. by email to **recruitment.cws@iift.edu** latest by **7th May, 2019**. The shortlisted candidates shall be called for written test, computer skill test and interview before the Selection Committee at the Centre for W.T.O. Studies (8th Floor), NAFED House, Siddhartha Enclave, Ashram Chowk, Ring Road, New Delhi - 110014. The date and time of the test and interview shall be intimated to the shortlisted candidates only in due course. It is also brought to the notice of all concerned that no TA/DA shall be payable to the candidates appearing for the written test and interview and that the candidates coming from outside Delhi shall have to make their own arrangements for stay in Delhi and the Centre shall neither pay nor arrange for their accommodation.
