1. **ELIGIBILITY CRITERIA AS ON 01.09.2019:**

1.1 **Educational Qualifications (Essential):**

Minimum class 10th/ Matriculation qualified with ability to speak in Hindi, English and conversant with local language.

Experience (Essential):

Must have Minimum 01 year of experience at airport in any of the areas or combination thereof, of Terminal Functions, Ramp Functions like Baggage/Loading/Unloading/Cargo and Aircraft Cabin Cleaning Area with any Airlines or Ground Handling Agency;

1.2 **Other Qualifications:**

- (a). Preference will be given to candidates experience with ILBS and BCAS approved GHA.
- (b). Candidates having Baggage Handling Training Course/ Certificate from National Skill Development Corporation (NSDC) will be an added advantage.

1.3 **Upper Age Limit as on 01st September 2019**: Not above 45 years

1.4 **Emoluments:** Rs. 15,000/- to Rs.20,000/- per month plus applicable allowances & benefits. Pay protection will be given to those who are working in other PSUs/Private Organizations.

2. SELECTION PROCEDURE:

Candidates who fulfil the eligibility criteria would be required to appear for Walk-ininterview on the above date, time and venue.

3. HOW TO APPLY:

- 3.3 A recent (not more than 3 months old) coloured passport size photograph of the full face (front view) should be pasted neatly in the space provided in the Application Form.
- 3.4 Candidates are also required to submit along with the application, an A/c Payee Demand Draft for an amount of Rs. 500/- (Rupees Five Hundred only) in favour of "AAI Cargo Logistics & Allied Services Company Ltd.", payable at NEW DELHI, as non-refundable Application Fee (Not applicable for SC/ST/Ex-Servicemen/Female candidates). - 3.5 Candidates working in Government/Semi-Government/Public Sector Undertakings or autonomous bodies must walk-in with the completed Application Form routed through proper channel or along with "No Objection Certificate" from their present employer.

4. GENERAL CONDITIONS:

- 4.1 The short-listed candidates will be considered for engagement on a Fixed Term Contract basis (FTC) initially for a period of one year subject to their Medical Fitness, prescribed for the position. - (b) The Contract could be terminated earlier at the discretion of the Management during the validity of the contract, and/or in the event of unsatisfactory performance. The job is transferable to any station in India.
