(b) Possessing the following educational and Experience namely :

(i) Bachelor of Science with Physics, Chemistry and Mathematics from a recognised University or Institute.

(ii) Two years experience in Teaching or Training or Research or Quality Control or Testing or Handling of Lab Equipment in Central or State Government or Union Territory administration or Public Sector Undertakings or recognised research Institution or University or semi Government or Statutory or autonomous organisation.

**Note 1.** The period of deputation (including short-term contract) including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed three years.

**Note 2.** The maximum age-limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.

4. Officers who volunteer and are sponsored by their Ministry/Department/State Governments/UTs Administration etc. for the post will not be permitted to withdraw their names later.
