- II. The Candidate applying for the post must hold Bachelor's degree or equivalent from a recognized university.
- III. Speed of 100 words per minute in Stenography (English)
- (a) Dictation :- 10 mts @ 100 WPM
- (b) Transcription :- 50 mts (English), Skill test shall be done in computer. An average of 5 key depressions for each work.
- (c) 5% permissible mistakes in transcription would apply in speed test.

2. Method of Examination:

The eligible candidates will have to appear in written examination in the following subjects and viva-voce to be conducted by the Arunachal Pradesh Public Service Commission, Itanagar.

The candidate who secured a minimum of 33% marks or more in each written examination papers and 45% or more marks out of aggregate total marks in the written examination papers will be eligible for Viva-voce. On the other hand, it will secured in the written examination papers and subject to ratio 1:3. The candidates securing less than 33% of marks in any of written examination paper shall not be eligible for appearing in the viva-voce.

- NOTE: The Commission will adopt Recruitment Test (Objective Type) before the Stenography speed test and written examination if it is deemed necessary to do so.
