2. Age Limit:-

- (a) For ESM Service rendered in Army/Air Force / Navy shall be allowed to be deducted from actual age of the individual and if the resultant age does not exceed maximum age prescribed for the post by more than three years, he shall be deemed to satisfy the condition regarding age limit (The benefit of relaxation of upper age limit by the length of military service plus three years available for ex-serviceman is extended for appointment against unreserved vacancies also).
