**07. SELECTION PROCEDURE:** - Candidates whose applications are found in order will be put through the following selection procedure.

<b>a) Trial Test in sportsevents:</b>	Those who fulfill the eligibility criteria will be put through the trial test in the sports event to which he/she belongs. The trial test will be qualifying in nature. This organization will not be responsible for any accident/injury caused to the candidate during the course of trial/test.
<b>b) Proficiency Test:</b>	Those who qualified in Trial test will be put up through the Proficiency Test of 40 marks. The minimum cut off marks in Proficiency Test for all events /sports will be 20 marks. Those who fail to secure the qualifying marks will be issued rejection slip. Additional marks out of 10 will be given to the candidate having meritorious certificate/achievement in the respective sports event.
<b>c) Final Selection:</b>	Final Selection of candidates will be made strictly according to merit taking into consideration the performance of the candidates during the course of Proficiency Test and the achievement/performance of the candidates during the last two years will also be taken into consideration.
<b>d) Medical Examination:</b>	The finally selected candidates will be medically examined and their appointment in the CISF would be subject to their fitness in the medical examination as per the instruction issued from time to time.
