- 2. All qualifications should be from Universities / Institutions recognized and approved in India.
- 3. All computations of age/ experience requirement / qualification shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement. The date of declaration of result / issuance of Mark sheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation on this account. Post qualification experience on a post/ level shall be counted only from the said date onwards.

Relaxation of age to Ex-Serviceman as per Govt. guidelines. For SC/ST candidates, the total years of post qualification experience will be relaxed by 1 year.
