- The appointment is purely temporary on ADHOC BASIS for a period not exceeding 6 (six) months, or till such time regular appointment against the vacant post is made, whichever is earlier, with effect from the date of joining. If the adhoc service is not extended further, the same will lapse automatically. However, the adhoc appointment shall not be extended beyond the period of two years.

- If employed under the State or Central Government or PSU/Autonomous body, applicants are

- 6. The adhoc appointment to the said post will be subject to medical fitness from the competent Medical Board for which he/she will be sent to the designated Medical Authority.
- The adhoc appointee shall not be granted any claim or right for regular appointment to any post of NEIGRIHMS.
- 8. No travelling or other allowance will be paid to him/ her for obtaining the medical or other certificates or for joining the post.
- 9. Accommodation will be provided to the faculty members appointed at the Institute, subject to availability of quarters.
- 10. Candidates holding DNB qualification qualifications would need to get their qualification verified by NBE as to whether it is as per the requirement of the Gazette notification No.MCI-12(2)/2010-Med.Misc dated 11.06.2012 and produce such verification certificate at the time of interview.
