Online applications are invited from the APST candidates for filling up of 1(one)post of Foreman, Group 'B' (Non Gazetted), under the Department of Printing ,Govt. of Arunachal Pradesh in the Pay Matrix ₹ 35,400-1,12400/-in level-6 plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The vacancy position is subject to variation.

1. HOW TO APPLY:-

(a) Candidates applying for the posts must mandatorily register themselves through **ONE TIME REGISTRATION (OTR)** in the Commission's website.

(b) Candidates are required to apply online using the website www.appsc.gov.in. Detail instructions for One Time Registration (OTR) and Online Application are available on the above mentioned website. The applicants are advised to submit only single application; however, if due to any unavoidable situation, if he/she submits another/multiple applications, then he/she must ensure that application with the higher Registration IDs(RID) is complete in all respect like applicants details, photograph, signature, Photo ID ,fee etc. The applicants who are submitting multiple applications should note that only the applications with higher RID shall be entertained by the commission and fee paid against one RID shall not be adjusted against any other RID.

(c) Those who have already registered in OTR need not register again and they can directly log in to fill up online form using their user ID and password.

2. ELIGIBILITY CRITERIA:-

(i) A Candidate shall not be less than 18 years and not more than 32 years of age as on **12-01-2021**. However, the upper age limit is relaxable to 5 years for APST candidate and another 5 years for APST candidates who are A.P. State regular Govt. Employees.

(ii) The date of birth accepted by the Commission shall be that which is entered in Matriculation/High School Leaving Certificate or Higher Secondary School Leaving Certificate or a Certificate recognized by an Indian University as equivalent to Matriculation or an extract from a register of Matriculates maintained by a University, which extract must be certified by the competent authority of the University or in the Higher Secondary or an equivalent examination certificate.

(iii) No other document relating to age like horoscope, affidavits, birth extract from Municipal Corporation, Registrar Economics and Statistics and Service Records shall be accepted .

3. **EDUCATIONAL QUALIFICATION** :- Candidates applying for the post must be 3 years Diploma in Printing Technology from a recognized University or Institution.

NOTE: However, students who have already appeared in final examination of the qualifying Diploma course and awaiting result shall also be eligible to apply. Such candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificate/Mark-sheets of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of examination/ Vice- Chancellor of the concerned University will only be accepted by the Commission on or before the date of Interview/Viva-Voce. Without the original certificate/Mark sheet they shall not be allowed to appear in the Viva-voce.

4. **METHOD OF SELECTION:-** The eligible candidate will have to appear in written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which selection will be finalized.

(i) Printing in Letterpress	-	100 marks
(ii) Printing Offset	-	100 marks
(iii) Other latest method of printing-		100 marks
(iv) Viva voice	-	40 marks
Total	-	340 Marks

The aspiring candidates may download the Syllabus of optional subject from www.appsc.gov.in.

A candidate who has secured a minimum of 33% or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-voce. In other words, selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva -voce

NB:- The Commission will conduct Recruitment Test (Objective Type) before written examination, if it is deemed necessary to do so.

5. **HOW TO APPLY:-** Candidates are required to apply online only through Website www.appsonline.in . Brief instruction for filling up of online application is available on the above mentioned Website.

6. **Scanned copies of following documents and information are to be attached/uploaded.**

- (i) Scanned signature of the candidate on white paper with black ink pen (size 20 kb to 60kb)
- (ii) Recent pass-port size photograph (size 40 kb to 100 kb)

7. The candidates who have been declared qualified in written examination will have to submit the following documents/Information to the Commission before the interview date.


- (i) Class X Certificate issued by Board/University. Age proof will be based on this only.
- (ii) Class XII Certificate with Mark-sheet.
- (iii) Diploma Certificate and Mark-sheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- (iv) APST certificate for APST candidate..
- (v) Intimation letter to HoD for those who are in regular Govt. service/NOC.

Qualified candidates will have to produce the above mentioned Certificates/Documents and Mark-sheets in original at the time of interview, failing which he/she will not be allowed to appear in the interview.

8. EXAMINATION FEE: Candidates are required to pay fee of Rs.100 (Rupees one hundred)only for APST candidates through online mode only.

9. The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination or selection will be final and no correspondence or personal enquiry will be entertained.
