2. **AGE LIMIT:** Maximum age of 25 years or less as on 31/01/2021. Upper age limit is relaxed by 5 years for SC/ST & PWD candidates and 3 years for OBC candidates.
3. **APPRENTICESHIP PERIOD:** The tenure of the Apprenticeship would be One **year** only which will commence from 4th February 2021.
4. **ESSENTIAL QUALIFICATION & ELIGIBILITY CRITERIA:**
a) Candidates who have passed four years B.E/ B.Tech course in the above mentioned engineering branches on or after 1st April 2018, from AICTE approved colleges / recognized Indian Universities for GEA. In case of Diploma Apprentices, the candidates who have passed three years Diploma course in ECE & CSE branches on or after 1st April, 2018.
5. **How to Apply:**
Eligible Candidates should enroll in the NATS portal (www.mhrdnats.gov.in) and apply for apprenticeship in ECIL Hyderabad through NATS online portal. NATS online enrolment procedure and applying to ECIL in the same portal is explained below at Point 9.
6. **METHOD OF SELECTION:**
Apprentices selections will be done based on the qualifying examination marks merit. (i.e BE/B.Tech consolidated marks merit for GEAs and Diploma consolidated marks for Diploma Apprentices)
7. **GENERAL CONDITIONS:**
a) Before applying, candidate should read the complete advertisement carefully and ensure that he / she has fulfilled eligibility criteria stated in the advertisement in all respects.
b) The Degree of Disability for PWD Candidates is 40% & above.
c) All qualifications should be from Indian Institutes recognized by Appropriate Statutory Authority.
d) The application is liable for rejection at any stage of recruitment process in case of suppression of facts/ furnishing of false information.
e) ECIL reserves the right to cancel / restrict / enlarge/ modify the selection process, if need arises, without assigning any reason.

STUDENT ENROLMENT PROCESS on www.mhrdnats.gov.in

Before proceeding to enrolment process the students shall have the following documents and information.

- Aadhaar Card: Format: PDF, Size: Less than 1MB.
- Qualifying Degree/ Provisional Degree Certificate clear-cut indication of passing status with division and percentage (Internet copy not allowed): Format: PDF, Size: Less than 1MB.
- Passport size photograph: JPEG, Size: Less than 200KB (4.5 x 3.5).
- Bank account details. Preferably State Bank of India account (Account details like Bank Name, Branch, IFSC code and Account Number)
- Valid Personal Email ID.
- Mobile number (Will be required to send / verify OTP)

Open any browser → Type in the address bar www.mhrdnats.gov.in → Click on Enroll Button (find at the top-right corner of the home page) → wait for a page to open from the drop down box select the appropriate and correct options for example “ I am **a Student** a permanent resident of _____ I would like to enrol myself in the NATS Portal. I **Have completed** my _____ (Without backlog) in the year _____ through **Regular** mode of education.

Let the page may open further and the select { I ‘have above data} (find at the bottom of the page) →

Enter Valid Mobile Number → Click on sent OTP → Enter One Time Password and Click Continue
→ Enter Name of student → enter Primary Email ID → Setup a Password → Confirm Password
→ Click on Save and Continue → Wait for Next Page to Open → Go to Bottom → Tick on Box (By clicking this box I agree to the above Terms and Conditions) → Click on Agree and Continue → Wait for Next Page to Open → Upload Yours Passport Size (4.5 x 3.5) file size less than 200 KB in JPEG format → Enter Name of the Student, Father's Name, Mother's Name, Enter Aadhaar Number, select Gender (Male/Female/ Others), Upload Government ID ({ Aadhaar Card with Complete Address} Scan copy in PDF format less than 1 MB Size).

→ Select Community, Minority Community and Person with Disability
→ Enter Communication Information i.e. Permanent Address and Present Address
→ Enter Bank Information i.e. Bank Name, Branch Name, Bank Account Number and IFSC Code
→ Click on save and continue → Let the Educational Details Page Open
→ Enter: Type of Education if Diploma after 10th or 12th or if Graduation after 12th or Diploma, Roll Number, Name of Technical Board/ University, Location and Name of the College, Branch/ Discipline/ Subject of study month of passing i.e. month of declaration of result, Percentage and Class Obtained.
→ Enter Elective Subject if Any, Professional Certificate Course if undergone.
→ Upload Qualifying Degree/ Provisional Degree Certificate clear-cut indication of passing status with division and percentage (Internet copy not allowed): Format: PDF, Size: Less than 1MB and → Upload Resume also of Size less than 1MB in pdf format
→ Click on save and continue – Let the preferences of Training Page Open
→ Select nature of Establishment, Field and Area Interest, Preferred State and City
→ Click on the box at bottom to agree terms and condition and then Click on save and Preview (Go Through the information furnished and if everything is correct Click on to Submit Button and → Take the Print of the Final Page Containing Yours Email ID, User ID and Password.
