**1. How to Apply**

- c. The candidate has to enrol himself/herself on [www.mhrdnats.gov.in](http://www.mhrdnats.gov.in) and get himself verified from the respective Regional Boards. After verification the student will receive 16 Digit Enrollment Number.

## 2. **Educational Qualification:**

Only Indian Nationals Candidates should have passed the Graduate/Diploma in Engineering / Technology in the above-mentioned streams/field/trades/branches/discipline, recognized by AICTE/UGC, on or after 01/04/2019.

## 3. **Mode of Selection:**

1. Selection will be through **Interview**.
