4	Description of Work	This study focuses on understanding population and nesting ecology of House Sparrows across elevation gradients in the Uttarakhand State. And for this nest monitoring using nest boxes at select sites will be carried out. Additionally, this project includes a molecular component to study the genetic structure of house sparrow populations so as to identify presence of subpopulations and their evolutionary history in the Uttarakhand Himalaya. Further, the project includes an ecotoxicology component to investigate the presence of pesticidesin house sparrows and possible correlation on the decline of the species in the State.
