**2. AGE:** Candidate should not be less than 18 Years of age as on 14.10.2021. Upper age limit for General Candidates is 25 Years, for OBC 28 and for SC/ST 30 years.

the training, the candidates will have to execute a Contract of Apprenticeship. Those who absent themselves are liable to refund the whole cost of their training as well as the amount received as stipend as determined by the Central Apprenticeship Advisor.

- p) Every apprentice who had completed the period of training will have to undergo a test to be conducted by the National Council for Training in vocational trade to determine his/her proficiency in the designated trade. Only on passing the test, a certificate of Proficiency in the trade would be issued by the National Council.
- q) The engagement and training are strictly in compliance with the provision of the Apprenticeship Act 1961 and there is no obligation for employment of Apprentices on completion of their training.
- r) The Apprentice after completion of the training shall have no right to claim any employment in ECIL.
- s) ECIL being highly protected establishment, Apprentices will be engaged only after submission of Character /Conduct certificate from the concerned institution and two character certificates certified by two different Gazatted officers. Selected candidates have to submit these certificates at the time of joining.
- t) A physical fitness certificate from a Civil Assistant Surgeon should be produced by the selected candidate at the time of joining.
- u) Only residents of all districts of **TELANGANA STATE** are eligible to apply.

**IMPORTANT:** Candidates who have registered in MSDE apprenticeship portal are required to submit their online application through ECIL website as mentioned above. Applications submitted on ECIL website shall only be accepted and considered.

The on-line application process will be operational from 02.09.2021(1000 hrs.) 16.09.2021(1600 hrs.)

After applying on-line, the candidate is required to take the print out of registered on-line application form with system generated application serial number. Please note down your application serial number, for all future references. The candidate can take re-print of his/her registered on-line application form before the last date for On-line registration. There will be no separate communication to any candidate on their non-selection at any stage.

The application is liable for rejection at any stage of recruitment process in case it is submitted with incorrect information. Further, if any other shortcoming is noticed (either at the instance of candidate or otherwise) even after Apprenticeship

commencement, his/her apprenticeship will be liable for termination forthwith. The candidate has **to quote his/her system generated online application number** for all future correspondence.
