#### 3. TERMS OF ENGAGEMENT & REMUNERATION:

- a) **Project Engineer** will be engaged initially for a period of THREE years which may be extended up to maximum of ONE year (Maximum tenure of 4 years) based on project requirement and individual performance. Candidates will be paid a consolidated remuneration per month of Rs.40,000/-, Rs.45,000/-, Rs.50,000/- and Rs.55,000/- for the 1st , 2nd , 3rd and 4th year of contract respectively.
- b) In addition to the consolidated remuneration indicated above, consolidated amount of Rs.12,000/- per year will be paid towards expenses like insurance premium, attire allowance, stitching charges, footwear allowance etc. in two equal installments. First installment will be processed in the first month's salary after joining and the second installment will be paid after completion of 6 months from the date of joining.
