# 2. PROCESS TO APPLY FOR APPRENTICESHIP AT PANIPAT THERMAL POWER STATION

- Once candidates have enrolled themselves on NATS portal, candidates need to log onto NATS portal using their USER ID/EMAIL ID and password.
- Once logged in, on the home page, candidates have to click on "ESTABLISHMENT REQUEST" and select option "Find Establishment" from drop down menu.
- Once candidates click on "Find Establishment", the page appears with two "Search criteria", i.e. Option to search by 1) Preferences and 2) Establishment Name
- Among the search criterion option select Establishment name, candidates need to type
   "PANIPAT THERMAL POWER STATION (A Unit of HPGCL)" and click on option "Search".
- Once candidates click on search, apprentice vacancies at PANIPAT THERMAL POWER STATION (A Unit of HPGCL) appears.
- Candidates need to click on Establishment name "PANIPAT THERMAL POWER STATION
   (A Unit of HPGCL)" and select "Apply" button.
- Once candidate click "Apply" button a message appears as given below "Successfully applied for the training program".

Before applying candidates must ensure that all their profile details (Caste, Educational background, Personal credentials etc.) along with aggregate percentage (refer calculation of percentage in eligibility requirements) are appearing correctly in their application. PANIPAT THERMAL POWER STATION will not make any revisions/corrections in the data submitted by candidates. Candidates are required to contact their respective BOAT office in case of any corrections.

- The candidates can confirm if they applied for the establishment by checking under the tab "Establishment Requests".
- New Last Date of advertisement completion online-15/03/2023. Tentative start Date
  of Apprenticeship training will be March 2023.

#### **IMPORTANT NOTE:-**

- PANIPAT THERMAL POWER STATION does not give any commitment/assurance on providing permanent/temporary employment to apprentices on successful completion of apprenticeship period.
- Furnishing of wrong/ false information will lead to disqualification and PANIPAT THERMAL POWER STATION will not be responsible for any of the consequences of furnishing such wrong / false information. If any of the above discrepancies w.r.t to eligibility parameters, furnishing of wrong intimation and/or suppressing of any material fact detected/notice even after engagement, his/her training will be liable for termination without any further notice.

Canvassing in any form during any stage of engagement process will lead to cancelation of candidature.

#### **GENERAL CONDITIONS:-**

- The engagement of apprentices will be governed by the Apprentice Act, 1961 / Apprentices
   Amendment Act, 1973 and rules thereof.
- The engagement as Apprentice trainees will be period of ONE YEAR only.
- Candidates selected as Graduate Apprentice Trainee shall be paid monthly stipend 9,000/-(Rupees Nine Thousand Only) and Diploma Apprentice Trainee shall be paid monthly stipend 8,000/-(Rupees Nine Thousand Only).
- NOTE: Candidate are "NOT" required to submit hard copy of application forms to PANIPAT THERMAL POWER STATION. The details filled in the online registration /application form will be considered final & no changes will be entertained w.r.t personal or and other details later on.
- Selection information will be sent over NATS portal and no hard copy will be sent to the
  candidates. All communications will be through the email ID/ Mobile number provided by the
  candidates in his/her online application.
- PANIPAT THERMAL POWER STATION will not be responsible for any loss/ non-delivery of email/ any other communication sent, due to invalid/ wrong email id or contact number.
- All the details provided by candidates given in the online registration form will be treated as
  final & no changes will be entertained. Any request for change in category
  (GEN/SC/ST/OBC-A Or B) once filled in the online Registration/Application Form will not be
  considered and accordingly concessions/relaxation applicable will not be extended.
- Depending upon number of applications & instruction of competent authorities, PANIPAT THERMAL POWER STATION reserves the right to reject /select/cancel the application received at any time at its sole discretion during the selection process.
- PANIPAT THERMAL POWER STATION reserves the right to determine the total number of apprentices to be engaged/candidates to be selected at any stage of selection process.
- Management reserves the right to restrict the number of candidates to be called for interview/medical tests without assigning any reasons.

All the candidates are required to remain updated at each step of the selection process by visiting NATS portal.

All queries pertaining to registration/& filling the form online on NATS portal may be addressed to Board of Apprenticeship Training (Northern Region).

- 3. Candidates are not eligible to apply for apprenticeship in case:
  - a) Awaiting the results of their final examination.

- b) Not completed the 18 years of age.
- c) If already Undergone apprenticeship training for any scheme or on basis of any other course in any organization for any duration.
- d) If already have Job experience of equivalent to 1 year Or more than 1 year
- e) The age of the candidate should be between 18 to 42 years as on the day of application.
- f) A relaxation in upper age is admissible as per the Govt of India guidelines for SC/ST/OBC/PH.
- g) Duration of the training: The duration of the training will be one year and contract would be terminated automatically after completion of the apprenticeship training period. Shortlisted candidates have to furnish undertaking that after completion of training they cannot demand employment.
- h) Selection will be made as per sole criteria/decision of PTPS HPGCL Authorities. The candidates aspired for doing apprenticeship, who had also having the desired qualification of Degree Or Diploma Or Both in the engineering field will be solely selected Or rejected as per decision of HPGCL authorities. Candidate merely applied online not count themselves as selected candidate.
- i) In case, it is detected at any stage of engagement or thereafter, that a candidate does not fulfil the eligibility norms and or/ that he has furnished any incorrect / false information / candidature will stand cancelled.
- j) This is only an opportunity for getting trained for improving employability of the candidates and there is no scope for employment in PANIPAT THERMAL POWER STATION. After completion of apprenticeship training, apprentices cannot claim right of employment on the grounds of completion of apprenticeship.
