READ THESE INSTRUCTIONS CAREFULLY BEFORE COMMENCING FILLING APPLICATIONS FOR TECHNICAL POST.

- 1. The candidate should carefully read the details of posts, requisite qualifications & experience, terms & conditions, fee, and other details posted on the website www.nhrdf.org and www.kvkujwa.org.
- 2. Candidate should submit his/her 'Application Form' complete in all respect alongwith bank draft & enclosures through registered post/speed post only on or before 24/04/2023 upto 5:00 pm.
- 3. Candidates should fill up Application Form and attach documentary evidence for essential qualifications, Publications. Award/Fellowship/externally funded project.
- 4. Candidate should have domicile of India since birth.
- 5. Candidate should attach following documents with the Application Form:
 - (i) Bank draft with prescribed application.
 - (ii) One latest colored passport size self attested photograph should be pasted on the Application Form, do not staple.
 - (iii) No objection Certificate from Employer for in-service candidate, if any.
 - (iv) List of publication in given format with NAAS rating 2023.
 - (v) Self-attested copies of essential qualification including testimonials, transcripts, certificates, degrees, NET, etc.
 - (vi) Experience certificates, if any.
 - (vii) Other supporting documents, if any.
