(wherever number grading is not available 'very Good' will be acceptable).The officers coming directly from the cadre should not be more than 56 years of age as on 1st April of the financial year in which the application are being considered.

	<p>5. The officer having experience in handling various preventive and punitive measures in detection, punishment of corruption and other malpractices are preferable.</p> <p>6. Officers, against whom any major or minor penalty was imposed in their career as a result of disciplinary proceeding, are not eligible for applying for the post of CVOs.</p> <p>7. Consequent to their selection to the post of CVO, if an officer does not join within the prescribed time, his/her appointment would be treated as cancelled and the officer concerned would stand debarred from all kinds of posting in Metro/RRTS Companies for a period of five years from the date of issuing orders of his/her appointment.</p> <p>8. An officer will not be considered for appointment as CVO in an organisation to which he/she belongs. Further, the officer being considered should not have worked (in the preceding 3 years) in an organisation/ office in any capacity having direct official dealings with the concerned Metro/RRTS Company in which he/she is being considered for appointment.</p>
