General Instructions / Conditions:


1. Indian Nationals (Eligible candidates) have to apply through "Online Application Portal (OAP)" of the Ministry of Ports, Shipping and Waterways (<http://onlinevacancy.shipmin.nic.in>). While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his / her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment, his / her services are liable to be terminated without any notice.
2. All qualifications should be recognized and approved in India by AICTE / UGC / appropriate Statutory Authority / Competent Authority.
3. The mere fact that a candidate has submitted the application against the advertisement would not bestow upon him / her the right to be called for written test / interview / considered for selection process.
4. Employees working in Central & State Government / Semi-Govt./Govt. Autonomous Bodies/CPSEs must apply through proper channel or submit No Objection Certificate at the time of interview.
5. The crucial date for determining the qualification, experience and age shall be 29/05/2023.
6. Vacancy advertised can be cancelled at the discretion of V.O.Chidambaranar Port Authority without assigning any reasons thereof.
7. V.O.Chidambaranar Port Authority reserves the right to shortlist, restrict the number of candidates for written test / personal interview on the basis of qualification & experience by adopting appropriate selection criteria.

The applicant has to register in the Online Application Portal. No application other than OAP shall be accepted.
- (b) A printout of the filled application in OAP alongwith recent passport size photograph affixed on the right hand corner of the printout and self-attested copies of education / experience / age certificate(s) shall be forwarded through proper channel to the address below so as to reach on or before 29/05/2023.
