Terms and Conditions for Contractual Appointment for Medical Physicist Post

1. The appointment is purely on Contract basis for a period of 12 months (1 year) extendable up-to maximum 2 years or till such time the regular appointments against the vacant posts is made, whichever is earlier, This appointment will not vest any right to the candidate to claim for permanent absorption in the institute or for continuing the contractual appointment, which may be renewed or terminated as decided by the Institute and the decision of the Institute in this regard shall be final and binding on the candidate.
2. The leave entitlement of the appointee shall be as per the Institute Policy.
3. The consolidated remuneration for the post of Medical Physicist will be Rs. 85,000/-per month (consolidated).
4. The appointee shall perform the duties as assigned to him/her. The Competent Authority reserves the right to assign any duty as and when required. No extra /additional allowances will be admissible in case of such assignment.
5. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc or any other benefit available to the Government servants, appointed on Regular basis.
6. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS.
7. The appointee shall be on the whole-time appointment of the AIIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of the contract.
