- (b) **Only those candidates whose documents are verified will be allowed to attend walk-in interview.**
- (c) The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria in all respects as on the date of interview.
- (d) The Dean, ESIC Medical College & Hospital reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all post without assigning any reason.

ELIGIBILITY CRITERIA

REQUIREMENT OF QUALIFICATION AND REGISTRATION	
Post	Educational Qualification
Medical Officer	MBBS from a recognized institution along with Medical Council registration (preferable: MD or equivalent qualification in Psychiatry)

Age Limit: Not exceeding 30 years as on date of interview.

Consolidated Remuneration: - Rs. 60,000/- (Rupees Sixty Thousand only). No other allowances in any form shall be admissible.

Roles/responsibilities of the Medical Officer - ATF

- a. Providing assessment and diagnostic service to the patients.
- b. Providing initial short term treatment as well as long term pharmacotherapy to the patients.
- c. Providing referral services to the patients – including referral for other health conditions, other social needs, as well as referral to the higher centre for management of complex cases of substance use disorders.
- d. Providing orientation to other departments/staff of the hospital (to enhance referral to the clinic)
- e. Assisting the nodal officer in day-to-day management and supervision of the functioning of the ATF.

General Terms and Conditions

Terms of Contract:

1. The engagement will be for **one year only** under consolidated remuneration basis.
2. The contractual engagement will be subject to the following:
 - a. Barring serious misconduct/irregularity, continuation of the incumbent would be based on satisfactory performance of the duties assigned.
 - b. The contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning any reason.

3. Rules for Reservation will be implemented as per Govt. of India instructions.
4. The engagement shall not confer any right or preference for regular appointment.
5. The Medical Officer will be entitled for one day paid leave for every completed month of service. No claim for any service benefits like Leave encashment, PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
6. Candidate in the Government Service should submit “No Objection Certificate” from the employer at the time of interview.
7. The candidates who are already employed must produce relieving order from the previous employer at the time of joining and NOC for taking up engagement with ESIC.
8. No TA/DA will be admissible for interview or joining.
9. The DEAN has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of engagement.
10. The Medical Officer so selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.
11. The Medical Officer at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
12. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on Aadhar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days.
13. They will also be required to attend emergency, floor duty and other clinical duty as assigned by the Competent Authority.
14. They will also be required to perform duties in other departments as assigned by the competent authority.
15. Selected candidates will have to join duty on or before the date indicated in the offer of engagement.
16. The Medical Officer so engaged will be required to enter into a contractual agreement for the purpose on a **stamp paper of Rs.100/-**.
17. The Selected Medical Officer candidate has to deposit security amount of **Rs.15,000/- (Rupees Fifteen Thousand)** in favour of ESI Fund A/C No. 1 payable at State Bank of India, Ashok Nagar, Chennai-78 and produce the demand draft at the time of joining. However, this amount will be appropriated towards administrative cost in case the candidate resigns/terminates his/her contract before completion of his/her tenure. The contract is liable to be terminated at any time without assigning any reason thereof after giving one month’s notice on either side or on payment of one month’s remuneration in lieu thereof.

- (ii) The applications of the candidates submitted on the day of walk in interview along with the requisite fee will be scrutinized by the scrutiny committee of the Institute and only the eligible Candidates will be allowed to appear for walk in interview before the selection committee. In case, the numbers of applicants are in the ratio of 1:20, the selection committee of the Institute may devise criteria for short-listing of the candidates which may include holding of a Screening Test.

- (iii) The selection for engagement as Medical Officer will be made solely on the basis of performance of the candidate in interview before the Selection committee. Merit list for selection will be prepared solely in accordance with the performance of the candidates in the interview. Reservation will be applied at this stage for selecting the candidates under each category.
- (iv) Result will be published on the website (www.esic.gov.in/recruitments).
- (v) ESIC Medical College and Hospital, KK Nagar, Chennai is in urgent requirement of Medical Officer. Hence, selected candidate will have to join immediately after receipt of the offer of engagement not later than the last date mentioned in the offer of engagement. Request for extension of time for joining the post will not be considered.

General Instructions:
