- Work experience certificates should invariably contain the details of service, work experience & time period.

For selection process candidates have to mandatorily produce documents pertaining to ESI & PF (as per applicability) or Salaried Account Statement (for the no. of years of experience) at the time of certificate verification process along (applicable for post at Sl.no.3, 4, 7, 8, 9, 10 & 11 only).
7. Candidates, who fulfil all the requisite parameters and QRs, shall only be allowed to appear for written test/Trade test/Proficiency test/Interviews. Candidates shortlisted for written test/Interview based on the initial screening of applications.
