6. The selection committee reserves the right to make changes or cancel or postpone the recruitment process without any reason thereof.

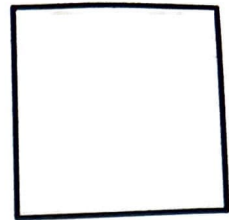
How to apply


