The selected candidate will be actively involved in studying the mechanisms of endothelial dysfunction and vascular remodeling in the context of breast cancer brain metastasis, with a focus on blood-brain barrier (BBB) integrity and vascular fluid dynamics. The project will involve:</li> <li>2. In vitro experiments with endothelial and cancer cell co-cultures.</li> <li>3. Gene knockdown/overexpression using viral vectors (e.g., AAV, lentivirus).</li> <li>4. Imaging techniques (confocal microscopy, immunofluorescence).</li> <li>5. Trans-endothelial electrical resistance (TEER), permeability assays, and 3D culture systems.</li> <li>6. In vivo metastasis models in mice and analysis of vascular function in brain tissues.</li> <li>7. Molecular biology techniques include qRT-PCR, Western blotting, immunohistochemistry.</li> <li>8. 3.	The number of vacancies indicated in the notification is tentative. IIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIT Dharwad reserves the right to NOT fill any of the posts advertised.
4.	No TA/DA will be paid for attending the Selection Process.
