Advertisement for the post of Junior Research Fellow (JRF) in the ANRF-funded extramural project titled **‘Evaluation of erythroferrone (ERFE) and hepatokine FGL1: The new erythroid regulators in children with thalassemia’** for a duration of 3 years. The recruitment will be for the first year and extendible depending on satisfactory annual assessment of performance and work progress by the ANRF.

Principal Investigator: Dr. Som Dev, Department of Biochemistry.

Applications are invited from eligible candidates for JRF position to be appointed purely on a temporary and contractual basis for the above-mentioned ANRF-funded Project. The shortlisted candidates will be asked to appear for an interview. No TA/DA will be paid for attending the interview. The details of the vacancies are given below:

Essential Educational Qualification:	MSc degree (Biochemistry, Life Sciences, Immunology, Biotechnology, Molecular Genomics, Bioinformatics etc.)
Desirable:	Working experience in Molecular techniques (such as ELISA, RT-PCR, Western blotting, Flow cytometry) including the patient’s blood sample handling. Additional qualifications/merits like ICMR-JRF, DST-Inspire, CSIR-UGC NET, DBT-BET, or equivalent national-level eligibility test will be appreciated.
Age:	Below 30 years.
Salary:	Rs 37,000.00 + 30% HRA

Application form along with a passport-size photograph and self-attested copies of all relevant documents, should be submitted in a single merged PDF format through Email to the following email ID som.biochem@aiimskalyani.edu.in within 15 days of publication of the advertisement on the website (**up to 5 PM of that 15th day including all holidays**).

SELECTION PROCESS

1. Eligible candidates may fill out the attached application form. The filled-up application form and a certificate of age, qualification, and experience should be emailed to (all documents merged as a single PDF file in the same order as given in the attached application form below).
2. The last date of application submission through email will be within 15 days of the advertisement notice on the institute webpage (**upto 5 PM. of that 15th day including all holidays**). The email should have the subject heading mentioning the "Application for the post of[write anyone whichever is Applicable) for **ANRF-funded** Project on 'Evaluation of erythroferrone (ERFE) and hepatokine FGL1 in Thalassemia' at AIIMS Kalyani. The improper Subject heading may lead to the rejection of the application.
3. Any application received after the stipulated time and deadline as mentioned above will not be considered.
4. The shortlisted Candidates will be published on AIIMS Kalyani Website (<https://aiimskalyani.edu.in>) before the interview. AIIMS Kalyani will not send any individual intimation to applicants. Candidates are hence requested to follow up recruitment notices on the website periodically.
5. The shortlisted candidates will be called for a screening written test and/or interview based on numbers of applications being received, the date and venue of these test/interview will be published on the AIIMS Kalyani website (<https://aiimskalyani.edu.in>) in time to time manner.
6. The test/interview will be conducted offline only. No TA/DA will be paid for attending the same.
7. Candidates should bring two photocopies of the application form and supporting documents along with original documents and a valid photo ID card for verification during the test/interview.
8. The decision of the selection committee appointed by the Executive Director, AIIMS Kalyani, will be final.
9. Results will be published on AIIMS Kalyani Website after the selection process is over and will be emailed to the selected candidate.

TERMS AND CONDITIONS

1. The candidates are responsible for ascertaining and ensuring their eligibility as per the prescribed qualification and experience. If any declaration given or information furnished by him/her proves false or if he/she is found to have wilfully suppressed any material or information, he/she will be liable for removal from service and such other action as the Government/ANRF may deem necessary. Even after qualifying in the selection process, the candidate may be disqualified during document verification if he/she does not fulfill essential eligibility criteria.
2. **Tenure:** The assignments are purely on a contract basis for a period of 12 months (which can be extended to a maximum of 3 years based on performance and funding availability). These Appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS Kalyani/ANRF, or continued contractual appointment.
3. **Expiry of Contract:** The contract will automatically expire on completion of the stipulated time or earlier in case of withdrawal of support by the funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. **Leave:** The leave entitlement of the appointee shall be governed by the ANRF/ICMR leave policy as amended from time to time.
5. **Accommodation:** The institute will not provide hostel or other accommodations to selected candidates.
6. Canvassing of any kind will lead to disqualification.
7. The prescribed essential qualification is minimum and merely possessing the same does not entitle any candidate for selection.
8. Applications incomplete in any aspect will be summarily rejected, and no intimations/requests will be made to the candidate. Candidates who will be called for the final interview will be based on the complete discretion of the Screening Committee, and no individual intimations will be given/sent to the candidate in this regard.
9. The decision of the Selection Committee at AIIMS Kalyani regarding the selection of candidates will be final, and no representation in any manner will be entertained in this regard.
10. The appointment is full-time, and private practice of any type is prohibited.
11. He/she is expected to conform to the rules of conduct and discipline applicable to the institute employees.

12. The screening test or final interview will be held at AIIMS Kalyani. No TA/DA will be paid for attending the same.

14. AIIMS Kalyani will send no individual intimation to applicants. It will be the responsibility of applicants to visit the institute's website.
