Bring hard copies of duly filled application in prescribed format along with one set of self-attested photocopies of their certificates and original certificates with two copies of recent passport size photo for verification
- 4. Late arrival (After 9:30 AM) of applicants for the interview will be considered as ABSENT.

- 2. **Age limit: RA:** Maximum: 40 years for men; 45 years for women. Relaxation in upper age limit to SC/ST (5 years), OBC (3 years), PWD (10 years) and other eligible categories shall be applicable as per Gol/ ICAR norms.
- 3. The candidates should compulsorily bring two copies of duly filled application form in the prescribed proforma only (Given in Annexure-I & II), two passport size photographs and one set of self-attested photocopies of their certificates/ mark-sheets/ experience proof etc. Applicants must bring with them original documents at the time of interview for verification.
- 4. Only the candidates having essential qualifications would be entertained for the interview.
- 5. No objection certificate from the employer, in case he/ she has an employment.
