

**Terms & Conditions:**

1. The appointment is co-terminus with the project. However, in case, the work and conduct is not found satisfactory, the services can be terminated any time after giving due opportunity of being heard to concerned employee. If he/she wants to leave he/she can do after giving one-month notice or one month emoluments in lieu thereof to the university.




2. The services of the employee will also be liable to terminate at any point of the time without assigning any reason because of non-release of grant by funding agency under whose project/scheme the job is advertised.
3. No TA/DA will be payable for appearing in the interview.
4. On expiry of the term of the project, he/she will be relieved and the university/department will not responsible for her adjustment in the university on any other post (It is made clear that there is no equivalent post in this university in the same identical project/scheme).
5. He/She will not be treated as a regular employee of the university and would not be entitled to any CPF/GPF or any other benefit admissible to regular employees.
6. He/She will be required to produce a medical certificate of fitness at the time of joining.
7. He/She should report for duty within 10 days from the date of issue of order of appointment, failing which per appointment will be treated as cancelled and may be offered to any other selected candidate.
8. His/Her place of work will be AICRP on FIM, College of Agricultural Engineering, JNKVV, Jabalpur
9. He/She must know the local language (i.e. Hindi) for proper communication with respondent during survey work.
10. He/She will be required to execute an agreement on a non-judicial stamped paper of Rs. 100/500/- before he/she is allowed to join the post.
11. He/She (candidate) will be required to submit the **demand draft of Rs. 100/-** (mandatory) in favour of **The Dean, College of Agricultural Engineering, JNKVV, Jabalpur** alongwith duly filled application form and required self-attested documents. However, SC/ST candidates will be exempted from submitting the demand draft of Rs. 100/- and the demand draft amount will not be refunded to any candidate in case of cancellation of advertisement at any stage or non-appearance of applicant in an interview.
12. The maximum duration of engagement of Young Professional (YP-I) is till **31/03/2026** or duration of project whichever is earlier.
13. As the work under the project is survey based, so the YP may be deputed on tour by PI/HOD concerned and will be entitled for reimbursement of conveyance charges/ DA equivalent to the entitlement of Grade-IV employees as mentioned in the TA rules
14. The Young Professional will be under the administrative control of PI.
15. The Young Professional will be entitled for leave as per university norms.
16. Their engagement for the scheme will be full time. They will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
17. This University may modify, add, delete and/or amend change the rules with the approval of the Vice-chancellor, JNKVV, Jabalpur
18. Other terms and conditions:
  - i. They shall be subject to the laws of secrecy of the country and will sign a declaration of secrecy and Non-Disclosure agreement before reporting (Annexure-I)
  - ii. The engagement will not constitute a regular job of appointment of any nature in the University.



- iii. During the terms of engagement shall comply with the standards of conduct. Failure to comply the same will become a ground for termination without notice.

The interview will be held 09 July 2025, at 11:00 (a.m. onwards) in the **Office of the Dean Faculty, Agricultural Engineering, JNKVV, Jabalpur**. No separate letter for interview will be issued. No TA/DA will be paid for attending the interview, in special circumstances the interviews can be preponed/ postponed and same may be communicated on the university website.
