

Attention is invited to the O.M. No. Edn/6/27/2014-HRD dated 1<sup>st</sup> July 2015, 13<sup>th</sup> July 2015 and Office Order No. Ag. Edn. 2(9)/2018-HRD dated 30<sup>th</sup> October 2018 issued by the Indian Council of Agricultural Research (ICAR) on the above subject. Consequent to the revision of emoluments and guidelines on service conditions for research personnel engaged in R & D programmes by the DST vide O.M. No. SR/S9/Z-08/2018 dated 30<sup>th</sup> January 2019, the matter has been further considered by the Competent Authority in the Council and the following revised emoluments payable for Junior Research Fellows (JRFs)/ Senior Research Fellows (SRFs) pursuing Ph. D. program in ICAR-AU System and Senior Research Fellows (SRF)/ Research Associates (RAs) working in various schemes of ICAR have been approved:
